The Trial will be open to affiliated members of the ACU and will be run in accordance with the National Sporting Code, the standing regulations for Trials of the Auto Cycle Union (Ltd), the following supplementary regulations and any final instructions to riders that may be issued on the day of the event.

- This event is a Non Stop Trial, Re. TSR22B.
- A graded hill climb may be included.
- The event will consist of the main trial and a concurrent 'conducted' trial for Youth C, D and E class riders and beginners.
