### Description of Event

West Glos & Dean Forest MCC will hold the Hangover/Boxing Day Trial. The trial will be open to affiliated members of an ACU club. The event will be run under the National Sporting Code, the Standing Trials Regulations of the ACU, the following supplementary regulations and any final instructions that may be issued.

- This event is a Non Stop Trial, Re. TSR22B.
- The event will consist of the main adult trial and a concurrent 'conducted' trial for C,D and E class riders and beginners.
- Disciplinary Action - Riders are reminded that any abusive or threatening behaviour towards officials, including harassment of observers, is in breach of NSC 11.01.7. This also applies to any member of the rider's entourage, including parents and guardians of youth riders.
- Competitors are reminded that ACU licences are to be produced at 'signing on'. NO LICENCE, NO RIDE!
- Competitors are reminded that; all combustion engine machines and Electric machines used by Youth competitors must be fitted with an operational lanyard operated cut out device, Re TSR8.

Sections will be marked with blue markers on the left and red markers on the right. White gates will indicate harder variations. Yellow gates will indicate easier variations.

- Expert will ride white variations.
- Clubman/Expert will ride white variations on designated sections (Clubman everywhere else).
- Clubman will ride standard 'blue on left, red on right'
- Sportsman + will ride clubman route on designated sections (yellow variations everywhere else).
- Sportsman will ride yellow variations.

- In the event of no mobile phone signal, there is a phone box at Broadwell crossroads (turn left out of the venue and drive up the hill for 400 metres).

- There will be a fire extinguisher at the signing on area.
- First Aider(s) will be identified at the riders briefing

Sections will be marked with blue markers on the left and red markers on the right. Harder variation will be marked with pairs of white gates.

It is proposed that E class riders ride the standard route, whilst C and D class riders will ride the white deviations. Beginners from other classes may also choose a conducted route.

D Class – As per TSR1 (born between 01/01/07 and 31/12/10)

E Class – As per TSR1 (minimum age 4 on 26/12/15 and born after 01/01/11)
