Description of Event

The Trial will be open to affiliated members of the ACU and will be run in accordance with the National Sporting Code, the standing regulations for Trials of the Auto Cycle Union (Ltd), the following supplementary regulations and any final instructions to riders that may be issued on the day of the event. The trial will be run under non-stop rules as per TSR-22B.

Coldbrook Farm, Longtown, Herefordshire. The start will be signposted off the A465 Abergavenny to Hereford road at Pandy.

Classes

Solo Adults of Intermediate and Novice status. Youth A, B and C can ride the main course. There will also be a separate conducted course for Youth C, D, and E riders.

Experts can ride on a no-award basis. The classes that are eligible for the Western Centre Clubman Championship are - Over 60, Twinshock, Pre65, Youth C, Youth D, Youth E.

Routes

Clubman marked with Red & Blue markers. **Sportsman Plus** identified by a sign at the start of the section

Sportsman variation marked with pairs of yellow markers (In accordance with Western centre guidelines).

Conducted Youth routes: Standard Route with Red & Blue markers. Expert variation marked with pairs of white markers.

Awards

Best performance on each Route for Adults and Youths. (Minimum 6 in class/route for award.

Option to donate equivalent to ACU Benevolent fund available.)

Results

Will be available on the Club and Centre's websites and only posted if you provide an SAE with your entry.

Entries

Entry Fee: £15. (£10 Yth) (**£20/£15 Yth, after closing date!**) **Cheques made payable to West Glos & Dean Forest MCC.**

Methods: **Post or deliver** your fully completed entry form (The last page only of this document.) to Entries Sec together with payment and any SAE's **Or, On-line entries can also be made via the ACU Members system. Entries are limited to 100 by order of receipt and will close 28th July or when full. Confirmation of entry will be displayed on the club's website or posted if an SAE is provided.

Entry fees will only be returned in the event of cancellation or postponement for more than 24hrs, and a portion of the fee may be retained for administration costs. The organisers reserve the right to refuse entry.

Start time

Starts 10:30am (Remember you need to be signed on 30 mins prior to your start time.)

Sections

Standard trials marking will be used throughout - 0, 1, 2, 3, 5. Trial is a no-stopping trial (TSR22B).

Disciplinary Action

Riders are reminded that any abusive or threatening behaviour towards officials, including harassment of observers, is in breach of ACU 11.01.7. This also applies to any member of the rider's entourage, including parents and guardians of youth riders.

Entry declaration: I the undersigned apply to enter the event described above and in consideration thereof: -

- I hereby declare that I have had the opportunity to read, and that I understand the National Sporting Code of the ACU, the ACU Standing Regulations, such Supplementary Regulations as have or may be issued for the event, and agree to be bound by them.
- I declare that I am physically and mentally fit to take part in the event and I am competent to do so. I confirm that I understand the nature and type of event I am entering and its inherent risks and agree to accept the same notwithstanding that such risks may involve negligence on the part of the organisers or officials.
- I confirm that I am not currently suspended from ACU permitted competition or on the ACU Stop List as a result of incurring a Concussion injury.

I understand that this form may be used in litigation as evidence that any serious injury will be principally the result of my voluntary decision to engage in a high risk activity.
- I consent to details of any injuries I may suffer at this event being passed between all medical services and the Clerk of the Course.
- I consent to the collection and retention of my personal information by the ACU.
- I confirm that the machine(s) as described below which I shall participate on shall be suitable and proper for the purpose. I confirm that I am eligible to compete on the machines for which I have entered.
- I confirm that if any part of the event takes place on a public highway, the machine(s) described below shall be insured as required by the Road Traffic Acts, or equivalent legislation, and that they will comply with the regulations in respect thereof.
- I accept responsibility for any items borrowed from the Organiser during the course of the event. These items include but are not restricted to (safety clothing, transponders, accessories). I understand that I am liable for the cost or replacement of any items lost or not returned and non-payment or non-replacement of items borrowed may affect my entry into subsequent events.
- I confirm that I have not been refused an ACU Licence, nor had an ACU Licence suspended, nor have I been excluded from any ACU competition
