All riders must hold a current ACU Affiliated membership card or licence. ACU Affiliation (Trials Registration) can be obtained by completing a form available from the ACU website <u>WWW.ACU.ORG.UK</u> Please allow 2 weeks for the ACU to issue a card. Please note: All ACU cards will be checked on the day.

Entries: Are limited to 50. Postal entries close on Wednesday 26<sup>th</sup> April or when full. Entry Fee: £15 Adults £10 Youth

Entry fees will only be returned in the event of cancellation or postponement for more than 24hrs, and a portion of the fee may be retained for administration costs.
